**RATES OF PAY**

**Barbuda Council Elections and by-election, March 2017**

Notice under Section 11 of the Barbuda Local Government Act, Cap. 44 concerning the appointment of Returning Officer, Presiding Officers, Poll Clerks and Tally Clerks and to provide for the amounts payable for their services in performance of such duties as may be assigned to them.

- (1) Every Returning Officer in whose Constituency the election is uncontested shall be paid the sum of \$1400.00 for his/her services in the performance of his/her duties as a Returning Officer.
- (2) Every Returning Officer in whose Constituency the election is contested shall be paid the sum of \$1800.00 for his/her services in the performance of his/her duties as a Returning Officer.
- (3) Every Presiding Officer shall be paid the sum of \$700.00 for his/her services in the performance of his/her duties as a Poll Clerk.

- (4) Every Poll Clerk shall be paid the sum of \$350.00 for his/her services in the performance of his/her duties as a Poll Clerk.
- (5) Every Tally Clerk shall be paid the sum of \$100.00 for his/her services in the performance of his/her duties as a Tally Clerk.
- (6) Every Messenger shall be paid the sum of \$50.00 for his/her services in the performance of his/her duties as a Messenger.
- (7) For rental of premises, a sum (not exceeding) \$100.00 shall be paid for such rental.
