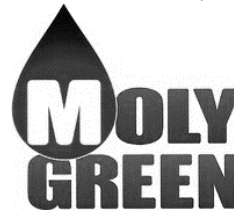

The mark depicts an hourglass within a rectangle, which is placed in front of an inverted triangular shape i.e. the apex of the triangle points downwards. The inverted triangular shape is punctuated on the left and right sides with four equidistant lines depicting the feathers of the wings. Each line slopes downwards towards the apex of the triangle decreasing in width from top to bottom. At the top of the triangle, on either side of the rectangle which contains the hourglass, the broadest line of the triangle which forms the wings, dips into a 'v' shape. The hourglass of the winged hourglass is formed by centering a square inside a rectangle and by placing an 'x' within both shapes.
